"A fire district in a small town south east of Roseburg was "given" new state of the art equipment. The federal grant did not include operating expenses. The service district was limited to their share of the county property tax, so for the first 3 years the community voted for an annual levy to raise 300% over the tax revenue. One year the levy failed and ever since the fire board members have had to cut staff and services. The greater needs of the excessive equipment are not being met. In better economic times it may have been possible for a rural community to have the luxury of services that an urbanized area would have, but now they are going bankrupt with few options.

If LTD continues expanding the massive federal project (EMX) with "free money", that is out-sized for the community, they too will go bankrupt. It may be that the first 3 phases of the project have led LTD to cutting service and reducing overhead over the last several months. Will successive phases only drive the stake deeper into the heart of what was once a functional service for those that need it?"

Robert Rubin has written to you about the EA Comments opposing West Eugene EmX, their message is as follows.

"Aug. 14, 2012

To whom it may concern:

Regarding the West Eugene EMX expansion .

I strongly believe that this proposed West Eugene EmX expansion project will have an immediate negative affect on the elderly and handicapped riders of LTD, and a permanent negative impact on the system as a whole. Since the beginning of these BRT expansions, basic services have been cut. The distance between the EmX stops is too great a distance for the elderly and alter abled. Additionally, LTD has not provided the feeder busses which are a vital component to the success of the system for the elderly and alter abled.

I attended the Eugene Human Rights Commission meeting on March 20, 2012, held at the Eugene City Hall complex.

The subject of EMX was brought up due to another Eugene group seeking support for the project from the Human Rights Commission.

I was deeply affected by the comments of HRC member Lorraine Kerwood.

Ms. Kerwood stated that “ her clients would be unable to get to the facility due to the construction”

From the EHRC 3.20.12 meeting minutes:

Ms. Kerwood said construction for the proposed route could negatively impact many businesses and agencies, including the nonprofit agency she worked for, which provided training to disabled individuals.

Small business owners feared the loss of customers and worried construction could cause them to close Permanently .

She used the EmX system to reach River Bend and appreciated the service but continued to have concerns about the West Eugene EmX proposal. Ms. Kerwood believed the issue was a human rights issue.

Next Step is an award winning training and recycling facility Next Step occupies over 35,000 square feet in three separate locations—much of which is training space for community members. To date, Next Step has trained over 8,500 individuals, many who are on the autism spectrum. Lane County, OR has one of the highest autism rates in the nation – one in every 80 children are diagnosed as having autism in our comminity. NextStep has refurbished over 28,000 computers, placing technology locally, nationally, and internationally and recycled over 10,500,000 pounds of electronics waste. Lorraine

is a member of the DEQ Oregon E-Cycles workgroup and a City of Eugene Human Rights Commissioner. She is the Eugene Area Chapter Coordinator for the Reuse Alliance. She is a past co-founder and Board Member of the GreenLane Sustainable Business Network, a member of the Lane Community College Computer Information Technology Advisory Committee, and is a proud Lane County Master Recycler. Lorraine is a passionate advocate for people on the autism spectrum, for trauma survivors, and for people who experience disabilities. Lorraine believes that all people are brilliant, no matter what label they carry, and should be treated with respect and dignity.

From the EHRC 3.20.12 meeting minutes:

Public Comment

Susan Beals believed Eugene had adequate bus service but service had been reduced in recent years, which disparately affected the community’s low-income residents.

Residents of the Uhlhorn Apartments

had difficulty accessing the bus and frequently had to arrange for RideSource transport instead. She worked near a low-income housing development and learned that each year LTD had met with complex residents to tell them that LTD would again be cutting their bus service. Now the complex, which housed mostly disabled and elderly residents, was five blocks away from the closest EmX stop and residents living at the far end of the complex had to walk nearly a mile to reach the stop. Previously, residents were able to go to a bus stop a few houses away. Ms. Beals did not think West Eugene EmX would further human rights and suggested that instead, EmX appeared to be taking away from the community's basic rights.

I urge you to reject the Lane Transit Districts plans to expand the EmX system into West Eugene.
