A recent letter to the Eugene Register Guard recommends that the Eugene City Council should reaffirm its support for Lane Transit Division's west Eugene extension of EmX. The letter writer states that while she walks with a cane, she won't mind walking longer distances to an elevated transit stop that features a weather-protected and elevated platform. The above testimonial illustrates how Lane Transit Division has been less than truthful in telling potential EmX riders just how far apart the transit stops will be on West 6th and 7th Avenues and on West 11th Avenue.

In reality, transit stops will be few and far between on the proposed West Eugene EmX route. While younger University of Oregon students don't mind walking to transit stops on LTD's first EmX route, senior citizens and others will be forced to walk longer distances than they do now when using the existing bus service on those same streets. It is one thing to walk a long distance in good weather but it will be much more difficult walking on wet or snow covered sidewalks in the middle of winter. Fewer transit stops will be more efficient for LTD but most riders will be burdened by longer walking distances to EmX transit stops.

Lane Transit District should be more truthful when selling the benefits of EmX in other parts of Eugene. I can't support the West Eugene EmX route for this and many other reasons.
